Our products are engineered specifically for the dentistry industry. We distribute over 40 million dental burs annually to a global network of trade customers, suppliers, and distributors across more than 90 countries. Our operations are based at two manufacturing sites, along with a warehousing, packaging, and dispatch unit located at Stephenson Drive, Waterwells Business Park, Gloucester, GL2 2HA, and Brunel Court off Stephenson Drive, GL2 2AL.
